3:05	Hailey Arnold, Youth Sector Representative <ul style="list-style-type: none"> • MADC Youth Liaison (YL) Update 	<ul style="list-style-type: none"> • Continue efforts to secure MADC Youth Liaisons (YL's) at high schools: Hailey is currently studying social work at BSU. As the Youth Sector Representative for MADC she has been reaching out to High Schools within the West Ada School District. Currently Hailey is connecting with Key Clubs, National Honors Society and Student Councils in the High Schools, to pick YL's that will be our connection into the schools. Hailey has reached out to roughly 10 different schools and have heard back from 5 with interested students. • Tana and Hailey have been working with Kendall to develop a packet that will be given to each YL. This packet discusses the goals of the YL position within MADC, commitment level, benefits, along with a controlled substance pledge. • Kendall will send the Youth Liaison Agreement out to CEC members to edit one of the bullet point's verbiage. • On the blackboard we have spots for each of these YL's as the school contacts. Also on the blackboard we have spots for each Sector Representatives. We have two Sector Representative Positions open: Government and Other Org. We are also looking for one additional religious and parent sector representative. • Nichole: Suggests that we move her sector representation from Health to Other Org, representing Mental Health, while Chakoma would continue to be the Health Sector Representative. • Reality Party is November 11th at Forward Movement Training Center. We have John Beranek scheduled to help facilitate and lead the youth for this event. The goal is to recruit Reality Party actors through MADC YL's.

We are also looking for a college aged guy to be the internet predator and a “submissive mom.” Kendall will work on a flyer with this information so Hailey can look for youth within her YL’s. The commitment is November 10th evening to practice and all day November 11th. ● Identify application for scheduling (organizing) volunteers: We are looking into a digital application to help coordinate volunteers. There are a couple out there, we are going to try and see if we can work with the free ones. We will look into Signup Genius. If you know of any please share with Kendall.
3:20	<p>Kendall Nagy, MADC Director</p> <ul style="list-style-type: none"> ● Sector Representatives ● Action Plan Review 	<ul style="list-style-type: none"> ● As we identify candidates for Government, Religious, Parent and Other, we would like to find speaking opportunities within each sector. So far this year we have presented within 6 of the 12 sectors. ● In addition, we want to get the MADC Webpage link on websites within the different sectors, such as businesses who are looking for prevention resources. ● Promote events on digital banners: Kendall is working with Mary Liz on looking into local businesses that have digital banners to help promote our upcoming events. ● Action Plan Review: Our Strategic Plan has three different logic models: underage drinking, prescription drugs and marijuana use. Once we figure out what the problems/concerns are, based on our data collection, we work on the seven different strategies to make change within the community. Then this information is put into our Action Plan. Kendall went through the Action Plan and has some information to share: ● Action Plan Updates: <ul style="list-style-type: none"> ○ Kendall will be updating the website. ○ Hailey and Tana will be working on YL’s for more youth involvement. ○ Each Sector Rep will be working on looking into local businesses and organizations that would like to add our link to other businesses pages as a prevention resource. ○ A large evaluation report will be given to us soon from ODP: this information will help us make some choices on going forward to see if we want to go for another grant. If we did go for a grant we would go for a Drug Free Communities Grant. This is roughly \$100,000 a year for 5 years if we were awarded.

- Cheryl is working on taking in requests for Red Ribbon Week. We will be teaching more drug prevention within the schools.
- Teens & Substance Abuse is coming up this spring. We need to work on the themes for each evening along with who we want to present. Teachers and counselors talked about wanting to have a panel of people who can speak towards drug citations within the schools: a judge, probation officer, SRO and counselor. The goal would be to educate what the law is, who gets involved, what steps are taken, etc...
 - We also have Natural High secured to come out for this and discuss that campaign and curriculum.
- Recovery Day Breakfast is September 26th at the Meridian Police Department, 7:30am-9:30am. This is the 12th annual breakfast to help celebrate recovery. Please join us!
- Timer Caps: Will be ordering a few of these as a resource for events. These timer caps are diversion deterrents. When the cap is opened the timer starts over, giving an indication to the owner of the prescription medication that the bottle has been opened by someone.
- Compliance Checks and Shoulder Taps: Scheduled for November. We are looking for youth volunteers to participate in this operation. They would have to be between 16 and 21 years old.
- Modifying Policy:
 - Density limits as they pertain to alcohol and vape shops.
 - Marijuana drug presentations, Not My Kid
 - Preemptive City Ordinance: We have the okay to move forward with building this from City Leaders.
 - Marijuana fact sheet to get out to our community.
- There has been talk about reestablishing the Every 15 Minutes event. Kendall has met with Steve Filer (one of the drug specialists for the West Ada School District). His input was that the Every 15 Minutes program is very powerful; however it's disruptive to school staff and requires a lot of resources to pull off.
- Fiscal year ends June 30th and that will wrap up the SPIFSIG grant. We won't have funding for movie ads or billboards after that point. We do have funds for ads through the holidays of 2017. If anyone has suggestions on ads for the movie theater please let Kendall know.
