(Jake) Would the GIS map also include the violation from schools? Maybe comparing GIS data to violation data showing who has gotten the program vs who hasn't. (Kati) It could be a layer to show what is implemented and what is not. (Kendall) The emphasis is the WASD data, MPD, and CMB through CDH.

(Jake) I also follow WADA for the stats on drug trends with athletes. (Kendall) Specific items that would be good infographics? We already do, or could use Facebook analytics, newsletter analytics, E&P data, add something for the trailer, MOU for Operation Parent Handbooks, Rx take-backs 2x yr. Anything else that we do? (Kati) Is there a way to track pounds of medications dropped off in the station lobbies? (Hailey) The Community Services Officers have a report number they use throughout the year to track when the bins are emptied, I wonder if that includes pounds as well? (Susie) Since it's through DEA, how do you find those numbers? (Kendall) I have those, I report those for the events. (Susie) Where would you find the stats for the data? (Kendall) You will not find our MPD lobby data in there. (Susie) The DEA has a lot of good data; it goes back 25 yrs. (Kati) Do you have confiscated vapes? (Hailey) Yes, I get them from the SROs and make bulletins with them throughout the school year. I keep it vague when creating those materials and make sure I do not mention school district, school, or the SRO who confiscated them. (Kendall) We want to make sure we advocate for WASD. (Earl) Can you do a comparison on the Rx take-back to compare as the years go on? (Kendall) I can run 5-yr analysis. (Kati) Mayor talking with Matt Todd on his podcast. Public Safety Levy plug. Finding more upstream prevention data to advocate for the levy. (Kendall) As city employees, we cannot talk about the levy. Only as constituents. (Kati) Maybe in an indirect way, providing education. (Anne) The Prosecuting Attorney (PA) team for the city. A lot of times officers will have a great arrest, write a report, and then the PA's office pleads it down. It becomes a defeating thing for our officers – why do they even try to get bad people off the streets when this happens? (Jake) There is a group being formed to advocate for the levy. Contact Anne Little Roberts if interested in advocating for the Public Levy Group. (Susie) I can't lobby with the Elks, but I can educate. I want to know where you find all this data. (Kendall) Not everything is public, some of it is through our partnerships. (Anne) Can share you if it's public? (Hailey) When it's a media release (MR), we can share the actual MR but if it's an active case we can't share it unless we get permission. Sometimes we do and sometimes we don't, it just depends. (Kendall) MR on an arrest with massive amounts of edibles, cocaine, mushrooms, etc. Followed up with another MR to update the public. (Hailey) Kendall and I monitor the police reports, and we pick and choose what we might want to share. For example, if we see a lot of overdose deaths on a specific drug, we will make a prevention bulletin, educating the public about the harms of that drug. (Kati) Idaho Youth-Led Campaign Alliance ad placements are data we could get. (Kendall) Go over contact sheet and look at goals for upcoming year. I wanted to touch base and see
