All in Favor? November Meeting Minutes Pass. At the beginning of December, I attended Meridian Parks and Recreation’s Children Winterland Festival. It was a fun event, I partnered with the Meridian Police Department where youth were able to do a fun craft and as they were doing their craft, I was able to talk to parents about the Parent Prevention Packets or other prevention resources. Overall, I had 73 prevention conversations.

This program will be for kids and will be launching in January.</p> <p>(Sydney) promoted 20 Yr. (Kendall) Spoke to Sydney regarding a fentanyl national campaign to see if any students at Renaissance High School are interested in applying. (Kati) Is that the SAMSHA one? (Kendall) Yes.</p> <p>(David) promoted 20 Yr. (Kendall) David dropped off some snacks and signed baseball cards for the baseball raffle basket.</p> <p>(Yoonwa/Kylee) promoted 20 Yr. and audio run through. (Kendall) We did AV walk through at WASD. It went great and we also got a layout idea for the room. (Yoonwa) Our violation data is down 50% for high school tobacco violations from 2022 to 2023. Violation data is down 27% for middle schools. Drug violations including paraphernalia for high schools increased by 6%. It’s good overall. (Kendall) Do you know what the contributing factors may be for these statistics? (Yoonwa) Implementing Catch My Breath when students are younger and students are receiving the education earlier. But there is a variety of factors of why the stats are down. (Milt) How are you identifying these particular cases? (Yoonwa) These are students that are caught with a vape or have drugs on them. These are students that have been disciplined for this and have received a school violation. (Kati) Do schools have vape detection devices? (Yoonwa) No.</p> <p>(Kati) There are mixed reviews on vape detection devices, but some schools put cameras to try and catch students as they enter a bathroom. The most successful method is finding a student in the act.</p> <p>(Jake) no updates</p>

Thank you for being supportive of me while I’ve been going through different jobs, still advocating for MADC. I am now with FY Idaho, thanks to Cheryl, I would have never learned about this organization. I will now be able to get into other areas besides Boise. I get to expand, I have been in the rural communities, and have been able to share about what we do and what resources we have.</p> <p>(Kati) promoted 20 Yr. Brought the raffle items for the basket: 9 Sun Safety Kits so please disperse as needed. Promoted 20-Yr to Gomez, WASD Drug Prevention Counselors. Updates outside of that, taught Catch My Breath to 10th grade students at Project STEM Academy, we went through all 4 sessions, pre-survey was interesting, still waiting on results from the post-survey. But overall the students were great. (Hailey) I am certified to teach others on Catch My Breath. During my training I came into contact with a WASD representative and we are going to touch base about getting the SROs in the classroom. (Kati) A school in Eastern Idaho invited Catch My Breath to a district that has all the of the high schoolers trained in the program and the high-schools teach the middle schoolers the curriculum. Catch My Breath highlighted the schools and the work they are doing. It is great that Idaho is implementing an evidence-based program.</p> <p>(Susie) Sent invitations to the Elks, want them to see what MADC is doing. Also promoted the 20-Yr at event for the Inter-Faith Sanctuary and promoted the 20-Yr to Drug Free Idaho. (Kendall) We extended an invite to Drug Free Idaho as well.</p> <p>(Anne) golf supplies for raffle, promoted 20 Yr. Invited Zamzows to the 20-Yr and the Chamber of Commerce. Spring planning, many of you have been with the coalition for a long time, please let us know your plans for serving into the next year. We will start the conversation about shifting/new CEC positions. (Hailey) I am requesting extra help for Kendall during the Summer because I will be on FMLA. I will be welcoming my first child in June 2024. (Kendall) The January 18th MADC meeting is one week before the 20-Yr. I wanted to propose it to the group: are we going to have a January 18th meeting? (Anne) Does missing the meeting mess with any planning for the 2024 year? (Kendall) No, we are good, we can still proceed without it. (Anne) I motion, we do not have the January meeting. (Susie) I second the motion. (Hailey) All in favor. Motion passes. (Susie) Can we have a brief meeting before the 20-Yr to regroup and know our tasks? (Kendall) We certainly can if necessary. We have a run-through on January 23rd 1-4PM, everyone is welcome to come. Kendall will send a calendar invite. The 20-Yr. raffle baskets are coming together, next week and the following week are going to be assembly.
